- This program is for customers who are using the MiniMed™ 670G or MiniMed™ 770G system to access SmartGuard™ auto mode technology
- This offer includes **one** free Medtronic transmitter per year (only if applicable) and **one** box of Guardian Sensor(3) per month to a maximum of 12 boxes at CAD \$99/box.
